# **DEADLINE EXTENSION: APPLY BY TUESDAY 31 JANUARY**

The DfE has confirmed that funding for all NPQs is available this year. In addition, from autumn 2022, state-funded schools with fewer than 600 pupils will be paid £200 for each teacher or leader they employ who undertakes an NPQ. More information can be found here.

## **EARLY CAREER FRAMEWORK**

This month, ECTs starting their Induction on the Star ECF programme will attend their ECF Induction. All schools with Early Career Teachers (ECTs) who start in January 2023 should ensure they are registered for their Statutory Induction to ensure their programme can begin. If this is something you are yet to do, below outlines the **three steps** you need to take to ensure your new ECTs are registered for their Induction.

There are three places to register ECTs for their induction:

- > The DfE online service
- > With an ECF programme provider
  - Star deliver the Teach First ECF Programme
- > With an Appropriate Body service

## Important reminder about registering your ECT

An ECT cannot start their Induction until registered with an Appropriate Body. Registering for an ECF Programme does not mean they are registered with an Appropriate Body, schools must ensure ECTs are registered for both an ECF Programme and an Appropriate Body. At the end of the ECT's induction assessment, it is the Appropriate Body that makes the final decision as to whether the ECT has successfully met the Teachers' Standards on the recommendation of their Headteacher/Principal.

# Star Appropriate Body Registration form DEADLINE

Appropriate Bodies must inform the DfE which ECTs started their Induction in January 2023. Any ECT not registered with an AB before **Friday 17 February 2023** may be unable to count their first term towards their Induction.
